Sat 11th May is Explorers Day – Blaxland Chamber of Commerce has invited us to be part of it, however we will decline. Monday 13th May is when the Crossing Re-enactment will pass through Warrimoo. WCA will meet them at the Seventh Day Adventist carpark to present them with a commemorative sash. Saturday 25th May – Largest Flyover in Australian history – event with hot air balloon at Glenbrook Park. WPS P&C to be consulted to see if a picnic at the school oval is a good idea as a Warrimoo event. 		
 Warrimoo Week – Saturday 9th November - we are on a minimalist programme for Warrimoo Week but have agreed to organise a BYO Ball in the Hall. The Citizen's Hall has been booked, further details to be agreed. Budget to be produced to determine what fundraising will be needed. 		
 Conservation Society report Tony Montgomery provided a report as to the latest activities of the Conservation Society. Mark advised that there was an encouraging result from a Mayoral and Deputy Mayoral delegation to the State Planning Minister where it was agreed to preserve our LEP rules within the any new LEP framework. Council are yet to review the legal effect of this but it was an encouraging meeting. 		
 Dogs Off Sports Grounds – The Sports Council has initiated this idea but it has not in fact been put to Council - Council has not considered this issue. Mark Greenhill's stated view is that everybody pays rates including dog owners, who are generally responsible. A lengthy community engagement would occur before any outright ban should be in place.
